Inter American University of Puerto Rico, Barranquitas Campus has expended and obligated \$142,389.96 of the total funds. The funds expended and obligated are related to technology equipment and protection material against COVID-19, to be used by the employees providing services to students. Acquisition of 125 portable computers for students use, faculty and administrative staff strengthening Distance Education. Acquisition of protective and safety materials for employees use and Acrylic Barriers were installed in student service offices. Reimbursement CARES Act to IAUPR. Refund of fees returned to students.
